Specialized Print accepts responsibility for the harmful effects its operations have on both the local and global environment and is committed to reducing them. The company will take a pro-active and balanced approach to managing business activities in an environmentally responsible way.

Policy Statement

Specialized Print aims to:

- Comply with all relevant environmental legislation
- Implement effective environmental management systems to ensure the environmental awareness of our workforce
- Use energy and raw materials efficiently and dispose of waste responsibly
- Actively promote the waste hierarchy (reduce, reuse, recycle) internally and to our customers and suppliers

This evidences a 27% reduction since our 2013 baseline carbon footprint was calculated. The 2013 baseline was a development of the 2008/09 carbon footprint and included diesel fuel, emissions from vehicle miles.

NOTE: Diesel fuel, emissions from vehicle miles was not included in the 2008/09 baseline calculation.
